## **Tenure-tracks**

**Dr. Behrang Kamali Shahdadi** is an Assistant Professor at the Department of Theoretical Economics of the Faculty of Economic Sciences. Dr. Kamali received his PhD in Economics at the University of Pennsylvania (USA) in 2016. His research interests cover market design, matching theory, and contract theory. In addition, he has seven years of experience in teaching. Before joining HSE University, Dr. Kamali worked at the Tehran Institute for Advanced Studies.

**Dr. Soubhagya Sahoo** will be joining the Department of Theoretical Economics at the Faculty of Economic Sciences as an Assistant Professor in December 2023. Dr. Sahoo received his PhD at the Indian Institute of Technology Kanpur (India) in 2023. His research interests include experimental economics, behavioural economics, economic development, labour economics, and applied micro-economics. Before joining HSE University, Dr. Sahoo worked at Centre for Research on the Economics of Climate, Food, Energy and Environment (CECFEE) of the Indian Statistical Institute.

Dr. Aleksei Pobedonostsev is an Assistant Professor at the School of Sociology of the Faculty of Social Sciences. Dr. Pobedonostsev received his PhD in Political and Social Sciences at the European University Institute in Florence (Italy) in 2023. His interests cover comparative political economy, economic development, and historical/comparative sociology. Dr. Pobedonostsev's current research concerns problems of the 'resource curse.' **Dr. Stefan Gužvica** is an Assistant Professor at the Department of History of the School of Arts and Humanities (St. Petersburg). Dr. Gužvica received his PhD at the University of Regensburg (Germany) in 2022. He has extensive experience working as a lecturer, researcher, organizer of academic events, and writer. Dr. Gužvica's field of research interests include the political and intellectual history of the Balkans and Central Eastern Europe.
